#### **ORDER**

Subject: Appeal registration No. EICOI/A/E/25/00036 dated 19.06.2025 made by Shri Parmod Siwach under Section 19(1) of the Right to Information Act, 2005 – reg.

### Facts of the Case:

Shri Parmod Siwach, vide online application registration No. EICOI/A/E/25/00036 dated 19.06.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the online reply dated 18.06.2025 submitted by CPIO, EIC in response to online RTI application registration No. EICOI/R/E/25/00048 dated 21.05.2025. Shri Parmod Siwach, vide RTI application dated 21.05.2025, had sought the information regarding his nomination for participation in 27<sup>th</sup> Session of CCFICS, scheduled at Cairns, Australia during 16-20 September, 2024. CPIO, EIC, vide reply dated 18.06.2025, informed that the information sought in the application is personal information and exempted from disclosure as per Cl. 8(1)(j) of the RTI Act, 2005.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 19.06.2025. The appellant in his appeal has stated that it appears that the CPIO, EIC has failed to take note that the information sought in the RTI application pertains to the appellant only and not related to any third party/person and therefore disclosure of any such information would not cause any invasion in the privacy of any individual. The appellant has therefore requested to kindly direct the CPIO, EIC to furnish the pointwise response to his RTI application.

#### Orders:

The Appellate authority has gone through all the relevant documents such as RTI Application dated 21.05.2025 submitted by Shri Parmod Siwach, the reply dated 18.06.2025 furnished by the CPIO, EIC and the instant appeal dated 19.06.2025. The information sought in point No. 9 to 11 of the RTI Application are exempted as they attract the provisions of Section 8(1)(h) of the RTI Act, 2005.

CPIO, EIC is directed to revisit the information sought by the RTI Applicant vide point No. 1 to 8 of the RTI Application and provide him the relevant information, if available in his records, within 15 working days or receipt of this order free of cost. The reply furnished by CPIO, EIC, stands revised to the above extent. Hence, the appeal of Shri Parmod Siwach hereby stands disposed of.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
