#### ORDER

Subject: Appeal registration No. EICOI/A/E/25/00040 dated 29.06.2025 made by Shri Sai Muni Meduru, Andhra Pradesh under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Sai Muni Meduru, Andhra Pradesh, vide online application registration No. EICOI/A/E/25/00040 dated 29.06.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 25.06.2025 in response to online RTI application registration No. EICOI/R/E/25/00053 dated 30.05.2025. Shri Sai Muni Meduru, vide RTI application dated 30.05.2025, had sought the information with reference to one line "Unsatisfactory Performance / Indiscipline of worker, Administrative Reasons, Expiry of the Agreement of Agency or any other reasons by the supplier agency" used by the nodal officer, EIC – Shri Nitin Y. Meshram, DD(T), EIC, in his reply to the RTI Applicant in response to his online PG application No. DOPAT/E/2025/0003080 dated 08.04.2025 and representation dated 22.04.2025. In response to the instant RTI application, CPIO, EIC, vide online reply dated 25.06.2025, had provided the information to the applicant.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 29.06.2025. The appellant in his appeal has stated that the CPIO, EIC has provided false and misleading information and requested to provide appropriate order to the CPIO, EIC to provide the information as per his RTI application.

#### Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 30.05.2025 submitted by Shri Sai Muni Meduru, the reply furnished by the CPIO, EIC vide online reply dated 25.06.2025 and the instant online appeal dated 29.06.2025.

It is observed from the perusal of facts on record that the instant matter is not as much about seeking information as it is about redressing the Appellant's grievance emanating from discontinuation of his engagement as an outsourced manpower through 3<sup>rd</sup> party vendor, in EIA-Chennai, Sub Office-Nellore. It is also learnt that the RTI appellant has already filed as many as 63 RTI Applications, 50 RTI Appeals & 01 PG application, that too all these after his disengagement. It is an abuse of RTI by the appellant. By filing multiple frivolous RTI applications out of vengeance of being disengaged, RTI cannot be turned into a tool for vendetta by one against an organization for some personal grievances.

Further, it is well settled in law that indiscriminate and impractical demands or directions under RTI Act for disclosure of all and sundry information (unrelated to transparency and accountability in the functioning of public authorities and eradication of corruption) would be counter-productive as it will adversely affect the efficiency of the administration.

In view of the above observations, the instant Appeal is bereft of merit and no further relief can be granted in the matter. However, the Appellant is advised to make judicious use of his right to information in future. The appeal is disposed of accordingly.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
