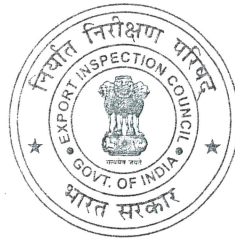

ORDER

Subject: Appeal registration No. EICOI/A/E/25/00043 dated 14.07.2025 made by Shri Rajiv Raizada under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Rajiv Raizada, vide online application registration No. EICOI/A/E/25/00043 dated 14.07.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 10.07.2025 in response to online RTI application registration No. EICOI/R/E/25/00058 dated 14.06.2025. Shri Rajiv Raizada, vide RTI application dated 14.06.2025, had sought the information regarding his pension breakup for the financial year 2024-25. CPIO, EIC, vide online reply dated 10.07.2025, had provided the information to the applicant.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 14.07.2025. The appellant in his appeal has stated that details of arrears paid, one of the information sought, had not been provided.

Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 14.06.2025 submitted by Shri Rajiv Raizada, the online reply dated 10.07.2025 furnished by the CPIO, EIC and the instant online appeal dated 14.07.2025. It is understood from the attachment enclosed with reply of CPIO, EIC that it bears the details of DA arrears paid in the month of May, 2024 and January, 2025.

CPIO, EIC is directed to revisit the information sought at point No. 5 of the RTI application and provide him further details or month wise details or bifurcation of arrears paid, as desired by the applicant, within 15 working days of receipt of this order, free of cost. With this, the appeal of Shri Rajiv Raizada hereby stands disposed of.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
