#### ORDER

Subject: Appeal registration No. EICOI/A/E/25/00038 dated 29.06.2025 made by Shri Sai Muni Meduru, Andhra Pradesh under Section 19(1) of the Right to Information Act, 2005 – reg.

### Facts of the Case:

Shri Sai Muni Meduru, Andhra Pradesh, vide online application registration No. EICOI/A/E/25/00038 dated 29.06.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 19.06.2025 in response to online RTI application registration No. EICOI/R/E/25/00049 dated 24.05.2025. Shri Sai Muni Meduru, vide RTI application dated 24.05.2025, had sought the information regarding Day to Day Work Performance, Enquiry Report, Investigation Report, Action Taken Report, Conclusion/Summary Report and Disposed Orders Report, on online grievance registration No. DOPAT/E/2025/0003080 filed by the applicant. CPIO, EIC, vide online reply dated 19.06.2025, informed that the information not available.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 29.06.2025. The appellant in his appeal has stated that the CPIO has provided false and misleading information and requested to provide the information as per his RTI application.

#### Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 24.05.2025 submitted by Shri Sai Muni Meduru, the reply furnished by the CPIO, EIC vide online reply dated 19.06.2025 and the instant online appeal dated 29.06.2025.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the online reply dated 19.06.2025 of the CPIO, EIC. However, it is understood that the issues, raised by the appellant in his online grievance registration No. DOPAT/E/2025/0003080 have already been covered in the reply sent to the appellant vide this office letter No. EIC/ADMN/GEN/GRIEVANCE/12 dated 08.05.2025. Hence, the appeal of Shri Sai Muni Meduru hereby stands disposed of, without any further directions to CPIO, EIC.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
