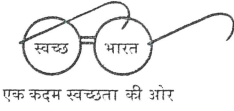

## ORDER

**Subject: Appeal registration No. EICOI/A/E/25/00044 dated 30.07.2025 made by Dr. Neeraj P. Awasthi under Section 19(1) of the Right to Information Act, 2005 – reg.**

### Facts of the Case:

Dr. Neeraj P. Awasthi, vide online application registration No. EICOI/A/E/25/00044 dated 30.07.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 23.07.2025 in response to online RTI application registration No. EICOI/R/E/25/00059 dated 29.06.2025. Dr. Neeraj P. Awasthi, vide RTI application dated 29.06.2025, had sought the information regarding service certificate for his employment in EIC/EIA-Mumbai from 23.09.2021 to 03.04.2024. CPIO, EIC, vide online reply dated 24.06.2025, had informed that record not available.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 30.07.2025. The appellant in his appeal has stated that he has not received any reply or information for RTI application.

### Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 29.06.2025 submitted by Dr. Neeraj P. Awasthi, the reply furnished by the CPIO, EIC vide online reply dated 23.07.2025 and the instant online appeal dated 30.07.2025.

At the outset, it may be clarified that under the provisions of the RTI Act, only such information as is available and existing and held by the public authority or is under control of the public authority can be provided to an RTI applicant. The PIO is not supposed to create information that is not a part of the record.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the online reply dated 23.07.2025 of the CPIO, EIC. Hence, the appeal of Dr. Neeraj P. Awasthi hereby stands disposed of, without any further directions to CPIO, EIC.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
