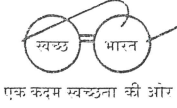

ORDER

Subject: Appeal registration No. EICOI/A/E/25/00046 dated 28.08.2025 made by Shri Jaysurya, Karnataka under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Jaysurya, Karnataka, vide online application registration No. EICOI/A/E/25/00046 dated 28.08.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 28.08.2025 in response to online RTI application registration No. EICOI/R/E/25/00066 dated 16.08.2025. Shri Jaysurya, vide RTI application dated 16.08.2025, had sought the information regarding overseas importers of turmeric fingers, red chilli and dry ginger from India for the last 03 years. CPIO, EIC, vide online reply dated 28.08.2025, had informed that the information sought is not available.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 28.08.2025. The appellant in his appeal has stated that the reply is unsatisfactory and requested to direct the CPIO to either provide the complete information requested, or transfer the RTI application to the appropriate public authority under Section 6(3) of the RTI Act.

Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 16.08.2025 submitted by Shri Jaysurya, the reply furnished by the CPIO, EIC vide online reply dated 28.08.2025 and the instant online appeal dated 28.08.2025.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the online reply dated 28.08.2025 of the CPIO, EIC. Hence, the appeal of Shri Jaysurya hereby stands disposed of, without any further directions to CPIO, EIC.

In case the appellant intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
