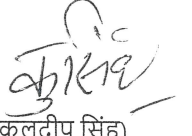

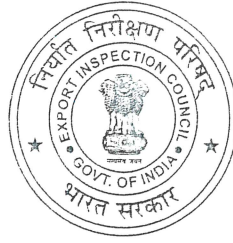
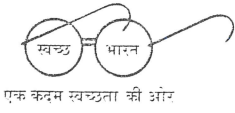

**ORDER**

**Subject:** Appeal registration No. EICOI/A/E/25/00045 dated 24.08.2025 made by MD. Ziaul Haque under Section 19(1) of the Right to Information Act, 2005 – reg.

**Facts of the Case:**

Mr. MD Ziaul Haque, an ex-EIA employee from Kolkata, vide online application registration No. EICOI/A/E/25/00045 dated 24.08.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply sent by CPIO, EIC vide online reply dated 13.08.2025 in response to online RTI application registration No. EICOI/R/E/25/00062 dated 17.07.2025. MD Ziaul Haque, vide RTI application dated 17.07.2025, had sought the information regarding his basic pension and gratuity etc. CPIO, EIC, vide online reply dated 13.08.2025 informed that the information requested relates to personal information the disclosure of which has no relationship to any public activity or interest and there is no obligation to give the information as per Clause 8(1)(j) of RTI Act 2005.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 24.08.2025 on the ground that CPIO, EIC has refused access to information sought.

**Orders:**

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 17.07.2025 submitted by Shri MD Ziaul Haque, the online reply dated 13.08.2025 furnished by the CPIO, EIC and the instant online appeal dated 24.08.2025. It is observed that the CPIO, EIC vide its reply dated 13.08.2025 has not provided the information sought on the ground that the information is exempted under the Section 8(1) (j) of the RTI Act, 2005. The said section provides an exemption from disclosing information that is "personal information" and has "no relationship to any public activity or interest" or would "cause unwarranted invasion of the privacy of the individual".

In view of the above, CPIO, EIC is directed to revisit the appellant's RTI Application dated 17.07.2025 and provide the relevant information, as sought by the RTI appellant, within 15 working days of receipt of this order, free of cost. With this, the appeal of MD Ziaul Haque hereby stands disposed of.

In case the appellant intends to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, the appellant may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
