CIRCULAR

Subject: Observance of Vigilance Awareness Week 2023 with focus on Preventive Vigilance measures: 3 months campaign (16th August, 2023 to 15th November, 2023) as prelude to VAW 2023 - reg.

This is in reference to CVC's Circular number 06/08/23 dated 2nd August 2023 wherein commission has decided to observe Vigilance Awareness Week from 30th October 2023 to 5th November 2023 to commemorate the birth week of Sardar Vallabhbhai Patel. The Commission has further desired that as a prelude to Vigilance Awareness Week 2023, activities as prescribed by CVC on Preventive Vigilance shall be undertaken as focus areas.

- 2.
