### ORDER

**Subject: Appeal made by Md. Ziaul Haque, West Bengal under Section 19(1) of the Right to Information Act, 2005.**

#### **Facts of the Case:**

Md. Ziaul Haque, West Bengal vide his online application dated 08<sup>th</sup> April 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his online RTI application request dated 27<sup>th</sup> February 2018.

Vide his online RTI application dated 27<sup>th</sup> February 2018, Md. Ziaul Haque, West Bengal had sought the information regarding details of pension of the applicant.

CPIO, EIC vide online reply dated 26<sup>th</sup> March 2018, provided the information to the applicant.

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his online application dated 08<sup>th</sup> April 2018.

The applicant, in his appeal, has requested to provide the information.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.
