Subject: Appeal made by Shri Mohan, Jaipur under Section 19(1) of the Right to Information Act, 2005.

Facts of the Case:

Shri Mohan, Jaipur vide his online application dated 17th April 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his online RTI application request dated 27th February 2018.

Vide his online RTI application dated 27th February 2018, Shri Mohan, Jaipur had sought the information regarding certified copies of attendance (manual and biometric) and leave in respect of Shri Sanu Jacob, Joint Director, EIA-Mumbai for the period October, 2017 to February, 2018

CPIO, EIA-Mumbai vide online reply dated 23rd March 2018, provided the information to the applicant.
