## **ORDER**

Subject: Appeal made by Ms. Manjusha, Andhra Pradesh under Section 19(1) of the Right to Information Act, 2005.

### Facts of the Case:

Ms. Manjusha, Andhra Pradesh vide her online application dated 25<sup>th</sup> March, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against her online RTI application request dated 25<sup>th</sup> February, 2018.

Vide her RTI application dated 25<sup>th</sup> February, 2018, Ms. Manjusha, Andhra Pradesh had sought the information regarding details for the post of Section Officer, Vacancy No. 1617/03 against Advt. No. 2016/02.

CPIO, EIC vide online reply dated 22<sup>nd</sup> March, 2018, informed that the recruitment process for the post of Section Officer, Vacancy No. 1617/03 against Advt. No. 2016/02 is under process.

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide her online application dated 25<sup>th</sup> March, 2018.

The applicant, in his appeal, has requested to provide the information.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to applicant and they state that they have nothing to append.

#### Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Ms. Manjusha.
