Governments establish product requirements to achieve policy objectives such as the protection of human health or the environment. The WTO SPS and TBT Agreements try to ensure that these requirements do not create unnecessary obstacles to international trade. WTO Members are required to notify other Members before adopting new measures if these are likely to affect international trade and provide an opportunity for comments. ePing enables timely access to these notifications and facilitates dialogue amongst the public and private sector in addressing potential trade problems at an early stage.

Codex Alimentarius [http://www.fao.org/fao-who-codexalimentarius/en/]

The Codex Alimentarius, or "Food Code" is a collection of standards, guidelines and codes of practice adopted by the Codex Alimentarius Commission. The Commission, also known as CAC, is the central part of the Joint FAO/WHO Food Standards Programme and was established by FAO and WHO to protect consumer health and promote fair practices in food trade. Codex standards ensure that food is safe and can be traded. The 188 Codex members have negotiated science based recommendations in all areas related to food safety and quality: food hygiene; maximum limits for food additives; residues of pesticides and veterinary drugs; and maximum limits and codes for the prevention of chemical and microbiological contamination. Codex food safety texts are a reference in WTO trade disputes.
