

ORDER

Subject: Appeal made by Shri Basudev Bhattacharya, Mumbai under Section 19(1) of the Right to Information Act, 2005 - reg.

Facts of the Case:

Shri Basudev Bhattacharya, Mumbai vide online application dated 12th September, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 22^{ad} June, 2020.

Vide RTI application dated 22nd Jüne, 2020, Shri Basudev Bhattacharya had sought the information regarding copy of calculation sheet, refixation, computation of arrears of pension.

CPIO, EIC vide reply dated 27th July, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 12th September, 2020.

The applicant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Basudev Bhattacharya.
