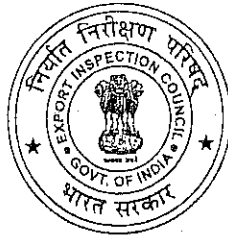
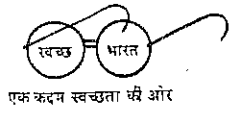

### ORDER

**Subject:** Appeal made by Smt. Santosh Rawal, New Delhi under Section 19(1) of the Right to Information Act, 2005 – reg.

#### **Facts of the Case:**

Smt. Santosh Rawal, New Delhi vide application dated 30<sup>th</sup> September, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated nil (received on 01.09.2020).

Vide RTI application dated nil, Smt. Santosh Rawal had sought the information regarding non-payment of her ACP / MACP.

CPIO, EIC vide reply dated 17<sup>th</sup> September, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 30<sup>th</sup> September, 2020.

The applicant in her appeal has requested for her MACP arrear since January, 2006 and also to start her pension otherwise she will have to go to the Court to resolve this matter.

#### **Orders:**

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Smt. Santosh Rawal.
