

ORDER 1

Subject: Appeal made by Shri Srinivasan Chandra, Chennai under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Srinivasan Chandra, Chennai vide online application dated 07th October, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 24th August, 2020.

Vide RTI application dated 24th August, 2020, Shri Srnivasan Chandra had sought the information regarding his pension.

CPIO, EIC vide reply dated 17th September, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 07th October, 2020.

The applicant in his appeal has stated that the CPIO has provided incomplete, misleading or false information and requested to direct the CPIO to provide copy of rule provisions under CCS (Pension) Rule, 1972 or copies of supporting orders / OM in this regard issued by DoPT under which rule the Competent Authority has accepted the voluntary retirement request of the applicant and relieved the applicant from service before three months notice period.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.
