ORDER

Subject: Appeal made by Shri Srikanth, Telangana under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Srikanth, Telangana vide online application dated 15th October, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 10th September, 2020.

Vide RTI application dated 10th September, 2020, Shri Srikanth had sought the information regarding present status of recruitment advt. No. 2016/02.

CPIO, EIC vide reply dated 15th October, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 15th October, 2020.

.The applicant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.
