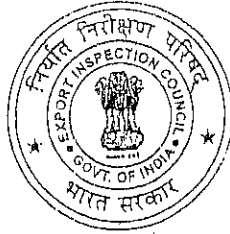
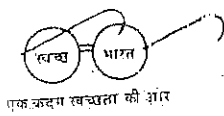

**ORDER**

**Subject: Appeal made by Shri Sandipan Mandal, West Bengal under Section 19(1) of the Right to Information Act, 2005 – reg.**

**Facts of the Case:**

Shri Sandipan Mandal, West Bengal vide online application dated 29<sup>th</sup> October, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 04<sup>th</sup> October, 2020.

Vide RTI application dated 04<sup>th</sup> October, 2020, Shri Sandipan Mandal had sought the information regarding export of Indian product with Made in India tags.

CPIO, EIC vide reply dated 28<sup>th</sup> October, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 29<sup>th</sup> October, 2020.

The applicant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

**Orders:**

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
