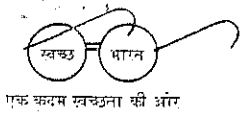

ORDER

Subject: Appeal made by Smt. Asha Singh, Thane under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Smt. Asha Singh, Thane vide online application dated 11th December, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 09th October, 2020.

Vide RTI application dated 09th October, 2020, Smt. Asha Singh had sought the information regarding compulsory retirement of the applicant under 56j.

CPIO, EIC vide reply dated 12th November, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 11th December, 2020.

The applicant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.
