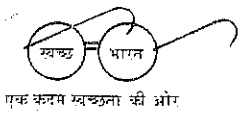

ORDER

Subject: Appeal made by Shri Pankaj Kodgirkar, Maharashtra under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Pankaj Kodgirkar, Maharashtra vide online application dated 15th December, 2020 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 30th October, 2020.

Vide RTI application dated 30th October, 2020, Shri Pankaj Kodgirkar, Maharashtra had sought the information regarding details of recruitment of technical officer under Advt. No. 2016/02.

CPIO, EIC vide reply dated 27th November, 2020, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 15th December, 2020.

The applicant in his appeal has stated that the CPIO has refused access to information requested.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
