

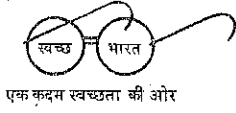

### ORDER

**Subject: Appeal made by Shri M. T. Francis Xavier, Kerala under Section 19(1) of the Right to Information Act, 2005 – reg.**

#### **Facts of the Case:**

Shri M. T. Francis Xavier, Kerala vide application dated 22<sup>th</sup> January, 2021 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 13 August, 2020.

Vide RTI application dated 13 August, 2020, Shri M. T. Francis Xavier, Kerala had sought the information regarding providing of copies of option CPF or GPF during the period October 1981 to March 1989 and relevant pages of service book.

CPIO, EIC vide reply dated 08th January, 2021, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 22<sup>th</sup> January, 2021.

The applicant in his appeal has stated that the CPIO has refused access to information requested.

#### **Orders:**

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
