### ORDER

Subject: Appeal made by Shri Sarath Kumar, Tamilnadu under Section 19(1) of the Right to Information Act, 2005 – reg.

#### Facts of the Case:

Shri Sarath Kumar, Tamilnadu vide online application dated 29<sup>th</sup> June, 2021 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 06<sup>th</sup> June, 2021.

Vide RTI application dated 06<sup>th</sup> June, 2021, Shri Sarath Kumar, Tamilnadu had sought the information regarding details of export of covishield & covaxin vaccine.

CPIO, EIC vide reply dated 29<sup>th</sup> June, 2021, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 29<sup>th</sup> June, 2021.

The applicant in his appeal has stated that the CPIO has not provided the details.

### Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.
