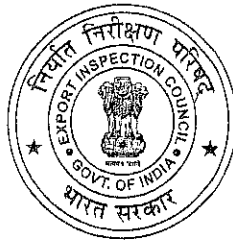
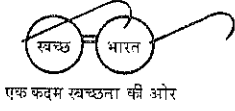

ORDER

Subject: Appeal made by Shri M. N. Gopidas , Kerala under Section 19 (1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri M. N. Gopidas, vide application dated 20th Feburey, 2021 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 01-01-2021.

Vide RTI application dated 01-01-2021, Shri M. N. Gopidas, had sought the information regarding reason for non disbursement of the Group Insurance Amount and Bonus for the financial year 2016-2017 .

CPIO, EIC vide reply dated 08th Feburey, 2021, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 20-02-2021.

The applicant in his appeal has requested the copy of the letter addressed to LIC, and has requested the Bonus for 2016-2017 on examination it was observed that CPIO has already communicated to applicant that bonous for 2016 -2017 has been paid by Agency on 16.07.2017.

Orders:

CPIO, EIC, is directed to provide the copy of the EIC letter dated 07-12-2017, as per the provision of Right to information Act, 2005 within 15 working days of receipt of this order free of cost .

This dispose off the appeal of Shri M. N. Gopidas.
