ORDER

Subject:- Appeal made by Smt. Prem wati, Delhi under Section 19 (1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Smt. Prem wati, Delhi vide application dated 09th March, 2021, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against RTI application dated 13th January, 2021.

Vide RTI application dated 13th January, 2021, Smt. Prem wati, Delhi had sought the information regarding non receipt of leave encashment on retirement against surrender leave.

CPIO, EIC vide reply dated 08th February, 2021, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide application dated 09th March, 2021.
