


### ORDER

**Subject:- Appeal made by Shri Fajalbhai V. Datania , Ahmedabad under Section 19 (1) of the Right to Information Act, 2005 – reg.**

#### **Facts of the Case:**

Shri Fajalbhai V. Datania , Ahmedabad vide application dated 12 April , 2021, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against RTI application dated 01 March, 2021.

Vide RTI application dated 01 March, 2021, Shri Fajalbhai V. Datania , Ahmedabad had sought the information regarding statement that copies of salary bills for the last ten months ( March 2006 to December 2006) etc .

CPIO, EIA-Mumbai vide reply dated 26th March, 2021, has provided the information to the applicant, as obtained from the concerned division.

The applicant in his appeal has requested to provide the relevant fair copy documents containing salary bills .

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide application dated 12 April , 2021.

#### **Orders:**

CPIO, EIC, is directed to provide fair and legible copies of the salary bills, as per the provision of Right to information Act, 2005 within 15 working days of receipt of this order free of cost .

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
