### **ORDER**

Subject:- Appeal made by Shri K. L. Laurian, Kerala under Section 19 (1) of the Right to Information Act, 2005 – reg.

#### Facts of the Case:

Shri K. L. Laurian, Kerala vide application dated 30<sup>th</sup> April, 2021, has made an appeal under Section 19 (1) of the Right to Information Act, 2005 against RTI application dated 24-02-2021.

Vide RTI application dated 24-02-2021, Shri K.L. Laurian, Kerala had sought the information regarding full size legible Xerox copy of entire service book etc.

CPIO, EIA-kochi vide reply dated 22 April, 2021, has provided the information to the applicant, as obtained from the concerned division.

The applicant in his appeal has requested to provide the relevant fair copy documents containing service book.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide application dated 30 April, 2021.

### Orders:

CPIO, EIC, is directed to provide fair and legible copies of the service book, as per the provision of Right to information Act, 2005 within 15 working days of receipt of this order free of cost.
