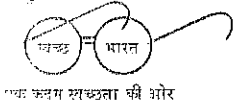

Subject: Appeal made by Shri Abhijith, Kerala under Section 19 (1) of the Right to Information Act, 2005.

Facts of the Case:

Shri Abhijith has made an appeal dated 04th June, 2021 under Section 19(1) of the Right to Information Act 2005, against his RTI application request dated 02nd May, 2021.

Vide his RTI application dated 02nd May, 2021, Shri Abhijith had sought the information regarding state wise details of Export /Products.

CPIO, EIC vide reply dated 04th June, 2021, informed that EIC has no information to share in the matter.

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act 2005 vide his online reply dated 04th June, 2021.

The applicant, in his appeal, has requested to provide the information.
