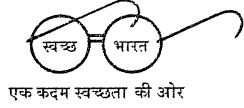

ORDER

Subject: Appeal made by Shri Augustin Dabre, Maharashtra under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Augustin Dabre, Maharashtra vide his online application No. EICOI/A/E/22/00003 dated 14th February, 2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against online RTI application No. EICOI/R/E/21/00029 dated 20th November, 2021.

Vide RTI application dated 20th November, 2021, Shri Augustin Dabre had sought the information regarding details of amount paid to the applicant at the time of his retirement.

CPIO, EIC vide reply dated 13th December, 2021 has provided the information to the applicant, as received from the concerned section.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 14th February, 2022.

The applicant in his appeal has requested that the CPIO may be directed to:

1. Provide information sought at f) and g) of the RTI application.
2. Provide amount of interest on voluntary contribution that has been added to interest on own subscription; and
3. Provide a copy of the ledger page of my subscriber account which the organization is legally bound to maintain for each employee in support of its claim "not available" for information against g).

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Augustin Dabre.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
