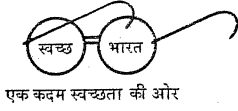

### ORDER

**Subject: Appeal made by Shri Manish Seth, Mumbai under Section 19(1) of the Right to Information Act, 2005 – reg.**

#### **Facts of the Case:**

Shri Manish Seth, Mumbai vide his online application No. EICOI/A/E/22/00004 dated 21<sup>st</sup> April, 2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against online RTI application No. EICOI/R/T/22/00005 dated 04<sup>th</sup> April, 2022.

Vide RTI application dated 04<sup>th</sup> April, 2022, Shri Manish Seth had sought the information regarding details of export of cream biscuits by M/s J. K. International Traders, Merchant Exporter.

CPIO, EIC vide reply dated 21<sup>st</sup> April, 2022 has provided the information to the applicant and requested to go through the milk and milk products notification provided by CPIO to resolve the query.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 21<sup>st</sup> April, 2022.


The applicant in his appeal has stated that the reply he received was for export of milk and milk products and has requested for clarification regarding non-milk products - biscuits.

#### **Orders:**

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.
