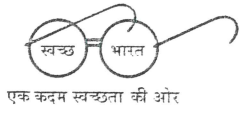

### ORDER

**Subject: Appeal made by Shri Parveen Kumar, New Delhi under Section 19(1) of the Right to Information Act, 2005 – reg.**

#### **Facts of the Case:**

Shri Parveen Kumar, New Delhi vide application dated 05<sup>th</sup> May, 2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 14<sup>th</sup> March, 2022.

Vide RTI application dated 14<sup>th</sup> March, 2022, Shri Parveen Kumar had sought the information regarding copy of his Service Book and Personal File.

CPIO, EIC vide reply dated 13<sup>th</sup> April, 2022 has provided the information to the applicant, as obtained from the concerned section and has requested the applicant to visit the EIA office after giving a notice of seven working days to inspect the records and identify the records for which the applicant desired to have copies of, these copies will be supplied.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 05<sup>th</sup> May, 2022.


The applicant in his appeal has requested that the CPIO may be directed to provide the information as requested.

#### **Orders:**

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC. Further, the Rule 288 of GFR 2017 is applicable to existing employees / new appointees. However, reply has already been given as under RTI Act, 2005.

This disposes off the appeal of Shri Shri Parveen Kumar.
