ORDER

Subject: Appeal made by Shri Rajiva Verma, Kolkata under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Rajiva Verma, Kolkata vide application dated 15th June, 2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 05th May, 2022.

Vide RTI application dated 05th May, 2022, Shri Rajiva Verma had sought the information regarding copy of Offer of Appointment, Joining Letter as Assistant Director, Promotion Order, Joining Letter as Deputy Director, Last Pay Certificate and Copy of Option Form of the applicant.

CPIO, EIC vide reply dated 10th June, 2022 has provided the information to the applicant, as received from the concerned section.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 15th June, 2022.

The applicant in his appeal has stated that the applicant has not received the information sought vide application dated 05th May, 2022 and has requested to do the needful.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Rajiva Verma.
