ORDER

Subject: Appeal made by Smt. Anima Bhattacharjee, Navi Mumbai under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Smt. Anima Bhattacharjee, Navi Mumbai vide application dated 24th August, 2021 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 16th February, 2021.

Vide RTI application dated 16th February, 2021, Smt. Anima Bhattacharjee had sought the information regarding copies of appointment letter / order, relieving office order after SVRS and order conveying sanction of various VRS benefits and their respective amounts.

CPIO, EIC vide online reply dated 08th March, 2021, had asked for additional fees of Rs. 20/-from the applicant, against the said RTI application.

Accordingly, in response to CPIO, EIC reply dated 08th March, 2021, the applicant had paid the additional fees on 17th August, 2021.

After receiving additional fees from the applicant, the CPIO, EIC has provided the information against the said RTI application vide online reply dated 07th September, 2021.

In response to the reply of CPIO, EIC, the applicant has raised a second appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated — September, 2021 (received on 27.09.2021).

The applicant in his second appeal has requested that suitable directions may please be issued to CPIO to immediately

- i.) Furnish the information sought by the applicant regarding appointment letter / order of late husband of the applicant.
- ii.) Supply legible copies of page no. 2 & 3 of the pdf file, and
- iii.) Refund the fee of Rs. 20/- as photocopies of the documents were not provided.

Orders:

CPIO, EIC is directed to provide the information and photocopy of page no. 2 & 3 as per provisions of Right to Information Act, 2005 within 15 working days of receipt of this order free of cost.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
