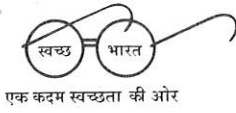

ORDER

Subject: Appeal made by Shri Rajesh Robin R T, Tamilnadu under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Rajesh Robin R T, Tamilnadu vide application dated 27th October, 2021 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 21st September, 2021.

Vide RTI applications dated 21st September, 2021, Shri Rajesh Robin R T had sought the information regarding details of recruitment of technical officers against advertisement No. 2016/02.

CPIO, EIC vide reply dated 14th October, 2021, refused to provide the information for S. No. 1 claiming that the information sought belongs to third party therefore cannot be shared as per 8(1)(j) RTI Act, 2005.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 27th October, 2021.

The applicant in his appeal has requested to provide the information for S. No. 1.

Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Rajesh Robin R T.
