ORDER

Subject: Appeal made by Shri Jagdishchandra G. Langhanoja, Rajkot under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Jagdishchandra G. Langhanoja, Rajkot vide application dated 20th December, 2021 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against RTI application dated 16th November, 2021.

Vide RTI application dated 16th November, 2021, Shri Jagdishchandra G. Langhanoja, Rajkot had sought the information regarding details of amount paid to the applicant at the time of his retirement under the head of CPF

ACPIO, EIA-Mumbai vide reply dated 26th November, 2021, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of ACPIO, EIA-Mumbai, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 20th December, 2021.

The applicant in his appeal has requested that suitable directions may be issued to ACPIO, EIA-Mumbai to

1. Provide information sought at f) and g) of the RTI Application;

2. Provide amount of interest on voluntary contribution that has been added to interest on own subscription; and

3. Provide a copy of the ledger page which the organization is legally bout to maintain for each subscriber account including mine in support of its claim "not available" for information against g).

Orders:

ACPIO, EIA-Mumbai is directed to revisit the RTI Application and provide the information as per provisions of Right to Information Act, 2005 within 15 working days of receipt of this order free of cost. This disposes off the appeal of Shri Jagdishchandra G. Langhanoja.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
