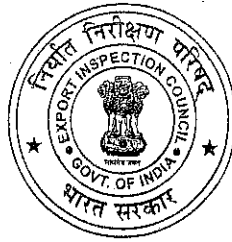
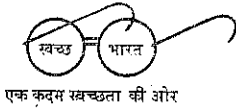

Subject: Appeal made by Shri Rajiv Raizada, Delhi under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Rajiv Raizada, Delhi vide his online application No. EICOI/A/E/22/00001 dated 10th January, 2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application dated 08th December, 2021.

Vide his RTI application dated 08th December, 2021, Shri Rajiv Raizada had sought the information regarding details of payment made to him at the time of his retirement in September, 2014.

CPIO, EIC vide reply dated 07th January, 2022, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated 10th January, 2022.

The applicant in his appeal has stated that the following points:


1. Not a single information sought has been provided by the CPIO.
2. Information was sought for the entire period of service whereas some abstract or extract has been supplied for the year 2014-15 only.
3. Even the information furnished does not appear to be complete.

Orders:

CPIO, EIC is directed to revisit the RTI Application and provide the information as per provisions of Right to Information Act, 2005 within 15 working days of receipt of this order free of cost.

This disposes off the appeal of Shri Rajiv Raizada.

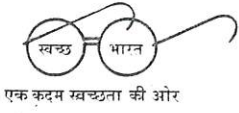

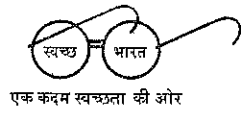

Facts of the Case:

Shri Rajiv Raizada, Delhi vide his online application No. EICOI/A/E/22/00002 dated 10th January, 2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application dated 09th December, 2021.

Vide his RTI application dated 09th December, 2021, Shri Rajiv Raizada had sought the information regarding copy of papers related to OM No. 45/57/97-P&PW(C) dated 19th December, 1997.

CPIO, EIC vide reply dated 07th January, 2022, has provided the information to the applicant, as obtained from the concerned division.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated 10th January, 2022.

The applicant in his appeal has stated that the following points:

- At point No. 1 of my RTI, copy of minutes of meeting was also sought. The same has not been provided by the CPIO.
- Copy of circular provided is a camera copy and therefore, its print out is coming black and therefore not readable. A properly scanned copy may therefore be provided.

Orders:

CPIO, EIC is directed to revisit the RTI Application and provide the information as per provisions of Right to Information Act, 2005 within 15 working days of receipt of this order free of cost.
