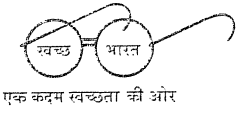

### ORDER

**Subject: Appeal made by Shri K. Rajendramany, Chennai under Section 19(1) of the Right to Information Act, 2005 – reg.**

#### **Facts of the Case:**

Shri K. Rajendramany, Chennai vide application dated 19.07.2023 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 02.06.2023.

Vide RTI application dated 02.06.2023, Shri K. Rajendramany had sought the information regarding details of handling the Govt. (EIA) fund by EIA Chennai, Competent Authorities of EIA-Chennai delegated with powers to accord approval, sanction and to sign Cheque for all payments effected during the period 2016-2021 along with the copy of orders empowered to them and the Internal Corporate Audit reports, CAG reports etc. for the above period.

ACPIO, EIA-Chennai vide reply dated 27.06.2023 informed the applicant that as per RTI Act, 2005 any information sought under RTI Act, which is related to third party or personnel information cannot be furnished as per Rule 8 (1) (J) of the Act. Therefore, the information sought cannot be furnished.

In response to the reply of ACPIO, EIA-Chennai, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 19.07.2023.

The applicant in his appeal has stated that the information sought by him are not falls under Section 8(1) (j) of the RTI Act, 2005 as these informations are not belong to any Citizen Information which related to personal information or related to third party or personnel information and purely are the information belong to Govt. Office / Institution (EIA) pertaining to handling the public / Govt. Funds and its procedures / orders set for according sanction and payment by the competent authority and its internal corporate audit reports etc. As such any public can sought information about these under RTI act. In view of the above non providing the information to us under Section 8 (1) (j) of the RTI Act 2005 legally not valid, violating the RTI act and not applicable to us. Hence, the applicant has requested to provide the information sought by him.

#### **Orders:**

The appellate authority has find no infirmity in the reply of ACPIO, EIA-Chennai, therefore disposes off the appeal without any further directions to ACPIO, EIA-Chennai. This disposes off the appeal of Shri K. Rajendramany.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
