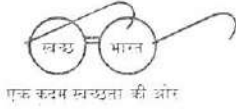

ORDER

Subject: Appeal made by Shri Nidheesh TP, Kerala under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Nidheesh TP, Kerala vide application dated 18.12.2022 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 26.10.2022.

Vide RTI application dated 26.10.2022, Shri Nidheesh TP had sought the information regarding copy of transfer order, movement register, dak inward and outward register.

CPIO, EIC vide reply dated 24.11.2022 has provided the information to the applicant, as received from the concerned section.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 18.12.2022.

The applicant in his appeal has requested to update all the transfer orders issued in the year of 2019 and 2020. The applicant has also stated that the reply of applicant's question No. 2 and 3 should not be denied because the details in the EIC tapal/dak inward and outward registers and the movements of any office does not details any personal information. Therefore, the applicant has also requested to provide the details.

Orders:

CPIO, EIC is directed to revisit the point No. 1 of RTI Application dated 26.10.2022 and reply to the appellant within 15 working days of receipt of this order free of cost.

The appellate authority has find no infirmity in the reply at point No. 2 & 3 of CPIO, EIC. Therefore disposes off the appeal under point No. 2 & 3 without any further directions to CPIO, EIC.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
