### **ORDER**

Subject: Appeal made by Shri Amal Kumar Paul, West Bengal under Section 19(1) of the Right to Information Act, 2005 – reg.

#### Facts of the Case:

Shri Amal Kumar Paul, West Bengal vide application dated 02.03,2023 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 22.01.2023.

Vide RTI application dated 22.01.2023, Shri Amal Kumar Paul had sought the information regarding copy of advertisement for the post of Laboratory Assistant Gr. II.

CPIO, EIC vide reply dated 20.02.2023 has provided the information to the applicant, as received from the concerned section.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 02.03.2023.

The applicant in his appeal has stated that the CPIO has refused access to information requested.

#### Orders:

The appellate authority has find no infirmity in the reply of CPIO, EIC, therefore disposes off the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Amal Kumar Paul.
