ORDER

Subject: Appeal made by Mohammed Rabiul Haque, Kolkata under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Mahammed Rabiul Haque, Kolkata vide application dated 07.08.2023 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 26.06.2023.

Vide RTI application dated 26.06.2023, Mahammed Rabiul Haque had sought the information regarding names of the Deputy Director (Tech) recommended by the DPC for promotion to the post of Joint Director (Tech) between the period 01.04.2010 and 28.02.2011 and copies of the reports of the Departmental Promotion Committee for promotion to the post of Joint Director (Tech) for the above mentioned period.

CPIO, EIC vide reply dated 21.07.2023 had informed the applicant that Name of the candidate and copies of the reports of the Departmental Promotion Committee for promotion to the post of Joint Director (Tech) belongs to a third party information and therefore cannot be shared as per 8 (1) (j) of RTI Act 2005.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 07.08.2023.

The applicant in his appeal has requested to direct CPIO to provide names of the Deputy Director (Tech) recommended by the DPC for promotion to the post of Joint Director (Tech) between the period 01.04.2010 and 28.02.2011 and copies of the reports of the Departmental Promotion Committee for promotion to the post of Joint Director (Tech) for the above mentioned period.

Orders:

The appellate authority has find no infirmity in the reply of CPIO, EIC, therefore disposes off the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Mahammed Rabiul Haque.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
