

#### Facts of the Case:

Shri Rakesh Mohan, Delhi vide application dated 22.09,2023 has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 02.08.2023.

Vide RTI application dated 02.08.2023, Shri Rakesh Mohan had sought the information regarding details of Dr. J. S. Reddy, Additional Director, EIC.

CPIO, EIC vide reply dated 24.08.2023 has provided the information to the applicant, as received from the concerned section.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 22.09.2023.

The applicant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

#### Orders:

The appellate authority has find no infirmity in the reply of CPIO, EIC, therefore disposes off the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Rakesh Mohan.
