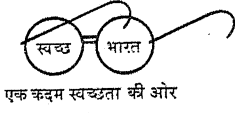

ORDER

Subject: Appeal made by Shri Satish Kumar Tandon, Delhi under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Satish Kumar Tandon, Delhi vide application dated 20.02.2024, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against his RTI application dated 27.01.2024.

Vide RTI application dated 27.01.2024, Shri Satish Kumar Tandon had sought the information regarding certified copies of the Minutes of the Council Meeting held in December, 2023.

CPIO, EIC vide reply dated 19.02.2024 had informed that the Minutes of Council Meeting have different agenda items and same are not open to Public, therefore information can not be shared.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 20.02.2024.

The appellant in his appeal has stated that the CPIO has denied to provide the minutes of the recently held Council Meeting held in Dec 2023 and has requested that directions be issued to the CPIO to immediately provide him the requested information.

Orders:

The appellate authority has find no infirmity in the reply of CPIO, EIC, therefore disposes off the appeal without any further directions to CPIO, EIC. This disposes off the appeal of Shri Satish Kumar Tandon.
