### ORDER

**Subject:** Appeal made by Ms. M. Amutha Devi, Tamil Nadu under Section 19(1) of the Right to Information Act, 2005 – reg.

#### Facts of the Case:

Ms. M. Amutha Devi, Tamil Nadu vide application dated 29.12.2023, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against her RTI application dated 28.08.2023.

Vide RTI application dated 28.08.2023, Ms. M. Amutha Devi had sought the information regarding Legal Hier Certificate of Late Mr. Balakrishnan Pillai.

ACPIO, EIA-Chennai vide reply dated 20.09.2023 had informed the appellant that “as per RTI Act, 2005, any information under RTI Act, which is related to third party or personnel information cannot be furnished as per Rule 8(1)(J) of the Act. Hence, the information sought in respect of Sl.No. 1 cannot be furnished.”

In response to the reply of ACPIO, EIA-Chennai, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 29.12.2023.

The appellant in his appeal has requested to direct the Technical Officer ACPIO (EIA) Chennai to furnish information sought by the appellant and thus render justice.

The appellant has also enclosed an IPO No. 18G 845707 dated 29.12.2023 of Rs. 20/- with his appeal dated 29.12.2023. The same is being returned herewith in original to the appellant.

#### Orders:

ACPIO, EIA-Chennai is directed to revisit the appellant's RTI Application dated 28.08.2023 and reply to the appellant within 15 working days of receipt of this order free of cost.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
