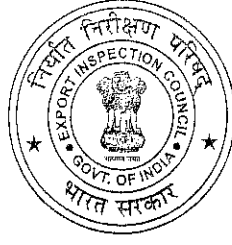
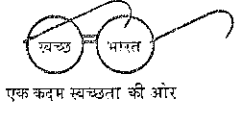

ORDER

Subject: Appeal made by Shri Ashish Shankar, Bihar under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Ashish Shankar, Bihar has made an appeal dated 22.11.2024 under Section 19(1) of the Right to Information Act, 2005 against reply to RTI application dated 12.08.2024.

Shri Ashish Shankar, Bihar, vide application dated 12.08.2024, had filed RTI application. The applicant, in his RTI application, has not sought any specific information. However, CPIO, EIC vide reply dated 29.08.2024, had informed the applicant to approach the appropriate forum.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide applications dated 22.11.2024.

Again, the appellant has not sought any specific information in his RTI appeal.

Orders:

The appellate authority has find no infirmity in the reply of CPIO, EIC as the matter does not pertains to this office. Therefore, disposes off the appeal of Shri Ashish Shankar, without any further directions to CPIO, EIC.
