### ORDER

**Subject: Appeal made by Shri Ajay Kapoor, Tamil Nadu under Section 19(1) of the Right to Information Act, 2005.**

#### Facts of the Case:

Shri Ajay Kapoor, Tamil Nadu vide his application dated 29<sup>th</sup> August, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 25<sup>th</sup> July, 2018.

Vide his RTI application dated 25<sup>th</sup> July, 2018, Sh. Ajay Kapoor, Tamil Nadu had sought the information regarding details of interview for the post of AD(T) under PH category, Vacancy No. 1213/02, Advt. No. 2014/01.

CPIO, EIC vide reply dated 23<sup>rd</sup> August, 2018, provided the information to the applicant

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his application dated 29<sup>th</sup> August, 2018.

The applicant, in his appeal, has requested to provide the complete information.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.

#### Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Ajay Kapoor.
