Subject: Appeal made by Shri Praveen Sakhuja, Delhi under Section 19(1) of the Right to Information Act, 2005 – RTI Application No. EIA-Delhi-2018-001 – reg.

Facts of the Case:

Shri Praveen Sakhuja, Delhi vide his email dated 01st February, 2019 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 10th December, 2018.

Vide his RTI application dated 10th December, 2018, Shri Praveen Sakhuja, Delhi had sought the information regarding marking of attendance by employees of EIA-Delhi.

CPIO, EIC vide reply dated 11th January, 2019, provided the information to the applicant.

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his email dated 01st February, 2019.

The applicant, in his appeal, has requested to provide the complete information as requested in his RTI application dated 10th December, 2018.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.
