Subject: Appeal made by Shri Praveen Sakhuja, Delhi under Section 19(1) of the Right to Information Act, 2005 – RTI Application No. EIC-18-05-001 – reg.

Facts of the Case:

Shri Praveen Sakhuja, Delhi vide his application dated 29th November, 2018 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application request dated 21st May, 2018.

Vide his RTI application dated 21st May, 2018, Shri Praveen Sakhuja, Delhi had sought the information regarding details of breakup of the 675 RTI applications filed by the applicant as per records.

CPIO, EIC vide reply dated 19th June, 2018, provided the information to the applicant.

Aggrieved by the reply of CPIO, EIC, the applicant has raised an appeal under Section 19 (1) of the Right to Information Act, 2005 vide his application dated 29th November, 2018.

The applicant, in his appeal, has requested to provide the listed information in his application.

CPIO, EIC has preferred not to raise any comment on the appeal of the applicant as they have already provided the information to the applicant and they state that they have nothing to append.
