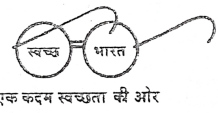

ORDER

Subject: Appeal made by Shri Vijay Kumar Dewan under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Vijay Kumar Dewan vide his application dated 06th June, 2019 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application dated 10th April, 2019.

Vide his RTI application dated 10th April, 2019, Shri Vijay Kumar Dewan had sought the information regarding Copy of Calculation Sheet for Revision & Re-fixation of Applicant's Pension.

CPIO, EIC vide reply dated 20th May 2019, provided the information as obtained from the concerned division to the applicant.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated 06th June, 2019.


The applicant in his appeal has stated that the CPIO has probably provided a gist of a part of re-fixation of basic pension only and not provided the complete information.

Orders:

CPIO, EIC is directed to attend the RTI application dated 10th April, 2019 and provide information to the applicant as per provisions of Right to Information Act, 2005 within 07 working days of receipt of this order free of cost.

This disposes off the appeal of Shri Vijay Kumar Dewan.
