### ORDER

Subject: Appeal made by Shri Amit, Delhi under Section 19(1) of the Right to Information Act, 2005 – reg.

#### Facts of the Case:

Shri Amit vide his application dated 03<sup>rd</sup> September, 2019 has made an appeal under Section 19(1) of the Right to Information Act, 2005, against his RTI application dated 25<sup>th</sup> July, 2019

Vide his RTI application dated 25<sup>th</sup> July, 2019, Shri Amit had sought the information regarding Copy of complete seniority list (designation wise) of EIC/EIAs employees as on date & details of posts employed in EIC/EIAs and its designation wise categorization as per EIC/EIA recruitment rule.

CPIO, EIC vide reply dated 22<sup>nd</sup> August, 2019, provided the information as obtained from the concerned division to the applicant.

In response to the reply of CPIO, EIC, the applicant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide his application dated 03<sup>rd</sup> September, 2019.

The applicant in his appeal has stated that the generic information such as seniority list should ideally be provided as part of suo-motu disclosure under Section-4 of the RTI Act, 2005. Further, the applicant has also stated that as the seniority list is not available in EIC website, it may be provided.

### Orders:

I find no infirmity in the reply of CPIO, EIC, therefore dispose the appeal without any further directions to CPIO, EIC.

This disposes off the appeal of Shri Amit.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
