

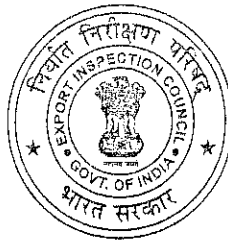
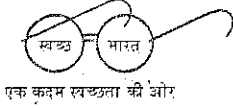

ORDER

Subject: Appeal made by Shri Shiv Prakash Saxena, Haryana under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Shiv Prakash Saxena, Ex- Assistant Director of EIA-Delhi, vide application dated 01.01.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide letter No. EIC/D (Q/C)/RTIC/24-25/038/2024/1992 dated 20.12.2024 in response to RTI application dated 22.11.2024. Shri Shiv Prakash Saxena, vide RTI application dated 22.11.2024, had sought the information regarding house addresses of Shri S. Laxmi Kanthan, Ex. Director (I&Q/C), Shri K. J. Srivastava, Ex. Addl. Director, EIA, Shri Rajiv Raizada, Ex. Addl. Director, EIC, Shri G. K. Srivastava, Ex. Joint Director, EIA and Shri M. Mohan, Ex. Dy. Director (Admn.), EIC. CPIO, EIC, vide reply dated 20.12.2024, had informed the applicant that the information sought belongs to third party, therefore cannot be shared as per 8(1)(j) of RTI Act, 2005.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide application dated 01.01.2025. The appellant in his appeal has stated that the reply of CPIO, EIC is totally illegal/arbitrary. CPIO has failed to provide the information under the provisions of RTI Act, 2005 and is liable for penalty.

Orders:

The Appellate authority has gone through all the relevant documents such as RTI Application dated 22.11.2024 submitted by Shri Shiv Prakash Saxena, the reply furnished by the CPIO, EIC vide his letter No. EIC/D (Q/C)/RTIC/24-25/038/2024/1992 dated 20.12.2024 and the instant appeal dated 01.01.2025.

Considering the provisions of Section 8(1)(j) of Right to Information Act, 2005, the information sought is apparently a personal information regarding the third party which is being sought for by the Appellant. Perusal of the information sought for by the Appellant does not disclose as to how the information sought for by him, is in relationship to any public activity or public interest. So, the information sought for by the petitioner, appears to be not bona fide and is in the nature of fishing inquiry having no relationship to public activity or public interest. There is no justification for disclosure of such information as the appellant could not claim these details as a matter of right and, therefore, the disclosure of the same is unwarranted.

Hence, in view of the above and also on scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the reply dated 20.12.2024 of the CPIO, EIC. Hence, the appeal of Shri Shiv Prakash Saxena hereby stands disposed of, without any further directions to CPIO, EIC.
