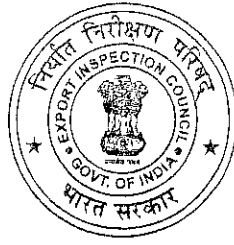
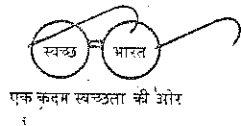

Subject: Appeal made by Shri Arnab Kumar Saha, West Bengal under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Arnab Kumar Saha, West Bengal, vide online application dated 29.01.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 29.01.2025 in response to online RTI application dated 06.01.2025. Shri Arnab Kumar Saha, vide RTI application dated 06.01.2025, had sought the information regarding details of export of sweets (Indian confectionery) from India. CPIO, EIC, vide online reply dated 29.01.2025, had informed to the applicant that the requested information does not pertain to this office.


In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 29.01.2025. The appellant in his appeal has stated that the CPIO, EIC has refused access to information requested.

Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 06.01.2025 submitted by Shri Arnab Kumar Saha, the reply furnished by the CPIO, EIC vide online reply dated 29.01.2025 and the instant online appeal dated 29.01.2025.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the online reply dated 29.01.2025 of the CPIO, EIC. Hence, the appeal of Shri Arnab Kumar Saha hereby stands disposed of, without any further directions to CPIO, EIC.
