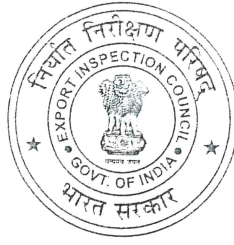
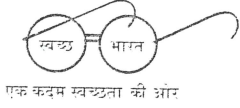

ORDER

Subject: Appeal made by Shri Amit Chawada, Gujarat under Section 19(1) of the Right to Information Act, 2005 – reg.

Facts of the Case:

Shri Amit Chawada, Gujarat, vide online application dated 28.05.2025, has made an appeal under Section 19(1) of the Right to Information Act, 2005 against the reply submitted by CPIO, EIC vide online reply dated 20.05.2025 in response to online RTI application dated 22.04.2025. Shri Amit Chawada, vide RTI application dated 22.04.2025, had sought the information regarding details of various Administrative & Financial Matters of EIC/EIAs employees. CPIO, EIC, vide online reply dated 20.05.2025, had provided the information to the applicant.

In response to the reply of CPIO, EIC, the appellant has raised an appeal under Section 19(1) of the Right to Information Act, 2005 vide online application dated 28.05.2025. The appellant in his appeal has stated that the CPIO has provided incomplete, misleading or false information.

Orders:

The Appellate authority has gone through all the relevant documents such as online RTI Application dated 22.04.2025 submitted by Shri Amit Chawada, the reply furnished by the CPIO, EIC vide online reply dated 20.05.2025 and the instant online appeal dated 28.05.2025.

On scrutiny of all the documents, particularly with reference to the RTI reply provided by the CPIO, EIC, the Appellate Authority finds no infirmity in the online reply dated 20.05.2025 of the CPIO, EIC. Hence, the appeal of Shri Amit Chawada hereby stands disposed of, without any further directions to CPIO, EIC.

In case you intend to prefer an appeal, as per Section 19 of the Right to Information Act, 2005, you may do so to Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi - 110067, within 90 days of the receipt of this letter.
